In continuation to this Ministry's letter of even number dated 17.07.2018 and Additional Secretary, Medical Education Department, Government of Madhya Pradesh's D.O. letter No.1889/2018/1/55 dated 18.07.2018 furnishing required undertaking, I am directed to convey the formal permission of the Central Government to establish a new Medical College at Khandwa, Madhya Pradesh in name & style of "**Government Medical College, Khandwa**" with an annual intake of 100 MBBS students for the academic session 2018-19 under Section 10 A of IMC Act, 1956.

2. This permission of the Central Government is accorded initially for a period of one year and will be renewed on yearly basis subject to verification of achievement of annual targets as indicated in your scheme. This process of renewal of permission will continue till such time the infrastructure and expansion of hospital facilities are completed as per norms of Medical Council of India. The next batch of students shall be admitted only after obtaining permission of the Central Government.


3. Admissions made in violation of the above conditions will be treated as irregular and action under IMC Act, 1956 & Regulations made thereunder will be initiated.

4. The Medical College shall contribute 15% of MBBS seats for which the LoP is granted for all India quota.

5. Discrepancies, if any, may be brought to the notice of MCI and Central Government.
