ELIGIBILITY CRITERIA

- 1. First preference for admission to the course would be given to the domicile of M.P. In case of non-availability, candidates from outside M.P. may be considered.
- 2. Reservation benefit only shall be given to the Madhya Pradesh domicile candidates.
- 3. Selection will be done strictly on the basis of merit of P.C.B. / Biotechnology in (12th standard of 10+2 scheme). The merit will be prepared on the basis of marks obtained in PCB / Biotechnology. CBSE passed candidates will be consider equivalent to other students.
- 4. Essential Qualifications:

Degree, Diploma & Certificate Courses- The candidate must have passed Higher Secondary 10+2 with Physics, Chemistry and Biology (PCB)/Biotechnology from recognized Board.

- 5. Under Paramedical Council affiliated vocational course, if the candidate is found to be eligible for Biology Group (10+2), then on the basis of merit in this subject, admission in the paramedical course will be considered.
- 6. Age of candidate should not be less than 17 years as on 31st Dec. 2020 and should not be more than 25 year as on 31st Dec. 2020. For Reserved Category (SC/ST/OBC) and Person with disabilities (PwD) age should not more than 30 years as on 31st Dec. 2020.
- 7. Candidates must be medically fit. They should bring recent certificate of medical fitness from Gazetted Medical Officer on the day of counseling.
- 8. If applicant has passed standard 12th Examination before year 2020 then he / she has to present Gap Certificate on the notarized paper.
- 9. In all mark sheets, certificates and related documents applicant's name should be similar. In case of any difference, related legal document should be attached.
- 10. Rules and Regulations for admission of Regular government employees (In-Service Candidate) in the Paramedical Diploma/Certificate course:-
- a) 10% seats are reserved for departmental in service candidate.

- b) Candidates who are already in service will be required to apply in the prescribed format (attached in application form) through proper channel (Dean / Joint director / Director / CMHO / Collector) along with N.O.C. from their employer. During issuance of N.O.C., Competent Authority must make sure that particular paramedical course will be helpful to the In-service candidate and in the government work.
- Those In-service candidates who are regular government employees for a period of last 5 years and those employees whose retirement shall happen after 5 years would be considered eligible. In case of candidates opting for diploma courses the service period should stretch for 7 years (2+5) whereas for candidates opting for certificate courses the service period should stretch for 6 years (1+5).
- Merit list will be prepared according to marks obtained in standard 12th Examination. On the basis of work experience after 5 years of service, In-service candidate will get 2 marks per year and maximum 10 years experience will be considered (i.e. maximum 20 marks).
- e) With reference to DME letter पृ. क्रमांक 748-51 स्था/अराज/2007 dated 05/11/2007 if N.O.C. is issued to the ineligible government employee other than paramedical staff then N.O.C. issuing Competent Authority shall be held responsible.
- f) Government employees working on ANM post will not be considered for any paramedical courses.
- g) On getting selected in the concerned course the competent authority will assure alternate arrangement.
- h) In case of more than 1 application forms the concerned authority shall make sure that preference is to be given to the senior candidate. Not more than 2-3 applicants should be permitted to attend the course so as a backup force is always available in the department at a given time.
- i) After completion of training the In-service candidate will not claim departmental recruitment & promotion against government promotion rules.
- j) Competent Authority must assure that In-service candidate is relieved only after issuance of allotment letter.
- k) To issue the N.O.C. and permission letter it is advised to the applicant and competent authority to go through the rules and regulations mentioned in the paramedical course brochure.
- During counseling procedure, In-service candidates will have to pay all types of fees and seat leaving bond similar to other candidates.
- m) Like other candidates, In-service candidates will have to do 3 months practical training/Internship in this institute after successful completion of the course. After completion of theory and practical examination of MPMSU / MPPMC, candidate shall report back to the original department and after passing the examination candidate will have to complete 3 month

- training/Internship in this institute.
- 11. These Paramedical curricula are full time courses. The candidate shall not register for any other degree / diploma whatsoever along with Paramedical Course. If found guilty, legal action will be taken against him.

Note:- After successful completion of course, student will have to complete three month practical training (Internship) in the Associated Hospital.

Seat distribution in different categories (UR/SC/ST/OBC) for the Degree / Diploma / Certificate courses for session 2020-21 will be done according to Madhya Pradesh Government established Rules and Regulations and will be displayed along with merit list on www.gmckhandwa.org.

1. 33 % seats for women are horizontally reserved in each category.

- 2. 10% seats are reserved for In-service candidates.
- 3. 10% seats are reserved for EWS candidates.
- 4. 3 % seats are reserved for Freedom fighter (FF) & Military personnel (MP).
- 5. Person with Disabilities (PwD): 3% horizontal reservation for the M.P. domicile candidate and in UR/OBC/SC/ST category.
- 5.a Only applicants having disability between 50 70% (PH-1) are eligible for reservation.
- In case of non-availability of PH-1 candidates, seats get filled with Person with Disabilities between 40 50% (PH-2).
- 5.c All PwD candidates should obtain certificate from District Medical Board and certificate from Vocational Rehabilitation Centre in Napier Town Jabalpur.
- 5.d Candidates having disability in hand/arm, vision, hearing and locomotor disability more than 70% are not eligible

SELECTION PROCEDURE

- 1. Selection will be done strictly on the basis of merit of P.C.B./ Biotechnology in (12th standard of 10+2 scheme). The merit will be prepared on the basis of marks obtained in P.C.B./Biotechnology. CBSE passed candidate will be consider equivalent to other students.
- 2. In case of more than one candidates having same marks, preference will be given to the candidate having higher marks in Biology. If relative merit of the candidate can not be decided even by these criteria, then preference will be given to the elder candidate.
- 2. Gap Certificate: If applicant has passed standard 12th Examination before year 2020 then he / she has to present Gap Certificate on the notarized paper.
- 3. Original documents of the students will be returned only after successful completion of course and handing over the No-dues certificate. If student leaves course before completion, then he has to submit the requisite amount, mentioned in the Seat leaving bond.

COUNSELING PROCEDURE FOR ADMISSION

- 1. For counseling / admission, candidate has to be present personally on the decided date. Candidates can choose seats depending on the available number of seats according to their merit.
- 2. No individual allotment letter will be issued. Applicants have to updated with the website www.gmckhandwa.org for notifications / counseling schedule / merit list etc.
- 3. For counseling procedure in the G.M.C. Khandwa, along with all original documents, applicant has to submit Rs 500/- (Five hundred rupees only) counseling fees (Cash / Demand draft) on the day of Counseling.
- 4. During counseling, if selected candidates will be required to deposit following documents and fees at the time of admission:
- a. Original marks sheet of class 12th
- b. Original School Leaving Certificate.
- c. Original Migration / Transfer Certificate.
- d. Date of Birth Certificate (10th class original mark sheet showing birth date)
- e. Caste Certificate of SC/ST/OBC
- f. Character Certificate
- g. Domicile Certificate
- h. Income Certificate of Father/Mother/Guardian joint income certificate of the current year with copy of income tax return / pay-slip (if applicable).
- i. For In-service candidates- N.O.C. issued by competent authority.
- j. If applicable, Person with Disabilities then, certificate from District Medical Board and certificate from Vocational Rehabilitation Centre in Napier Town Jabalpur.
- k. If applicable, Freedom fighter (FF) certificate (issued from District Collector) / Military personnel (MP) certificate from competent authority.
- 1. Gap Certificate: If applicant has passed standard 12th Examination before year 2020 then he / she has to present Gap Certificate on the notarized paper.
- m. In case of difference in the name of candidate in any certificates / mark sheets/ other documents, then related legal document should be attached.
- n. Soft copy of all original documents in C.D. and two sets of attested photocopies of the above mentioned certificates.
- Note:-i) Candidate failing to comply with the above requirements will be disqualified for admission to the course & candidate next in the merit list will be offered the course.

- ii) All the original documents submitted at the time of admission will be returned to the candidate after successful completion of course and getting No-dues certificate from account section, library, sports section, Hostel warden, Laboratory and Associated departments.
- 5. On the basis of merit-cum-option, counseling will be done in following order of the category –
- i) ST

- ii) SC
- iii) OBC
- iv) UR

If eligible candidate is not available in the reserved category then vacant seats will be filled in the following order –

- a) Vacant ST category seat will be filled by SC category candidate.
- b) Vacant SC category seat will be filled by ST category candidate.
- c) If eligible candidate from ST and SC category is not available then vacant seat will be fill by candidate from OBC category.
- d) If eligible candidate is not available in ST, SC and OBC category then vacant seat will be fill by unreserved candidate (UR).
- 6. If eligible candidate from Person with Disabilities (PwD), Military personnel (MP), Freedom fighter (FF), In-service candidate (IS) is not available then vacant seat will be converted to open seat.
- 7. Eligible candidates from ST, SC, OBC category have choice to opt course from open category according to their position in the merit list.
- 8. Paramedical course opted by candidate during counseling will not be changed in any condition.
- 9. Applicant will not get any type of travelling allowance (T.A) for the counseling procedure.
- 10. During procedure of counseling if any document needs to be further scrutinized by the issuing officer, money expenditure in the process would be bearded by the candidate.

In case of failure in the Certificate Course main examination, fee will be payable as per rules.

Note:- 1. Security deposit will be returned only after successful completion of Paramedical course.

- 2. In the fees mentioned above, there will be automatic 7.4% increase in the fees every year.
- 3. Like any other candidates, In-service candidates have to pay complete fees.
- 4. Candidates of reserved category will get scholarship as per established Madhya Pradesh government rules. For this, candidate would have to present joint income certificate of Father/Mother/Guardian of the current year and certificate of reservation category.
- 5. If fee is not deposited in time Rs.100/- per week as late fee will be charged. Candidate will not be allowed to get the examination form till No-dues is obtained from the Account Section.

IMPORTANT POINTS RELATED TO FEES

- 1. Candidates of all categories taking admission in Degree / Diploma / Certificate courses have to compulsorily deposit prescribed first year fees at the time of Counseling. Paramedical course fee can be deposited as Demand draft / RTGS / NEFT at the time of Counseling in the account of GOVERNMENT MEDICAL COLLEGE KHANDWA in the account No. 37773559136, IFCS code SBIN0012159. Admission will be confirmed only after deposition of complete fees and all necessary documents.
- 2. Seat leaving bond: Candidates taking admission in the Degree / Diploma courses have to submit seat leaving bond in the name of Dean & CEO Government Medical College Khandwa. For degree course, seat leaving bond of Rs. 150000 /- and for Diploma courses, seat leaving bond of Rs. 50000 /- is to be submitted on Rs. 500 /- notarized stamp paper at the time of Counseling, in which it should be clearly mentioned that, if for any reason candidate leaves the course without completion then he / she has to submit requisite amount of seat leaving bond in the institute. Seat leaving bond will be applicable from the day of admission.
- 3. All paramedical courses are being started in an autonomous institute. So candidates of all categories including In-service candidates have to submit tuition and other fees at the time of admission and also timely afterwards. Fees submitted at the institute is non-refundable (except Caution money, which will be returned after successful completion of course).
- 4. Reserved category candidates: Eligible candidates of SC/ST/OBC can apply to tribal welfare department / Backward Classes and Minorities Welfare Department, Madhya Pradesh for fees reimbursement on specified website portal. As per rules, reimbursement of the fees will be done in the candidate's account. Beneficiary candidate should possess account in the State Bank of India.
- 5. Before commencement of next session candidate has to deposit tuition and other fees in the stipulated period, otherwise a fine of Rs.100/- per week shall be charged.

- 6. If candidate gets suspended because of bad behavior/illegal activities/ antisocial activities/violation of rules/any other reason or candidate leaves the course without completion not be returned and candidate has to submit requisite amount of seat leaving bond.
- 7. At times, candidate has to pay extra fees for computer, stationary, games, magazine fees, other fees.
- 8. If candidate gets failed in any educational session then he / she has to appear in supplementary examination and will have to pay prescribed examination fees to the university. Duration of course will be extended if candidate fails in the examination, so candidate has to pay examination fees and prescribed fees for extending period.

ADMISSION CANCELLATION RULES / PROCESS

- If it is found that candidate has taken admission by hiding the information / false documents / wrong incomplete information or admission is given by mistake, then in this condition admission will be cancelled without any prior information. Decision of head of the institute will be undisputed and final in such conditions.
- Student will have to join in the concerned department within 15 days of admission, otherwise admission will be cancelled. If due to any unavoidable reasons, candidate is unable to join in the concerned department then candidate has to present appropriate application through concerned officer, otherwise admission will be automatically cancelled.
- If candidate is absent unofficially for continuously 7 days without any information then admission will be automatically cancelled. Duration of this absence will not be adjusted in any kind of leave.
- If it is found that, candidate is involved in any antisocial activities / misconduct inside or outside the college and hospital premises / uninformed absence in the class / involved in the non-educational activities / ragging then institute head has power of any disciplinary action and suspension / cancellation of admission can be done.
- Admission cancellation by candidate: If applicant / student participates in counseling procedure and deposits fees and original documents and wants to cancel the admission then he / she has to submit seat leaving bond amount through demand draft and along with original receipt of bond amount with affidavit. Application for admission cancellation has to be present to Dean & CEO Government Medical College Khandwa. Only after approval of Dean admission will be consider cancelled and original documents will be returned to the candidate.

EDUCATIONAL RULES AND CODE OF CONDUCT FOR STUDENTS

- 1. To maintain dignity of the institute, all students have to maintain discipline and proper behavior and follow all rules and regulations of the institute.
- 2. Students have to strictly follow all rules and regulations of MPMSU / MPPMC / GMC Khandwa.
- 3. Attendance 75% in theory and 80% in practical is required to appear in the examination. Attendance in the theory and practical will be calculated separately. If student fails to fulfill minimum attendance then he/she will not be eligible for examination and therefore duration of course will be increased and also concerning departments will not forward reimbursement and scholarship letter of candidates of reserved category.
- 4. Students should follow "Zero tolerance policy" with reference to attendance made by MPMSU Jabalpur and show cause notice will be given to students in case of any unauthorized leave. If there is repetition of unauthorized leaves then information will be given to parents. If even after this, the student is on repeatedly unauthorized leave then he/she will be deprived from appearance in the examination organized by Institute / MPMSU and information of cancellation of enrollment shall be given to MPMSU.
- 5. If attendance falls short by ≤ 5 % required for the examination then Dean will recommend for the appearance of student in the examination only after suitable and satisfactory reason.
- 6. Time to time, students and parents should monitor about attendance and studies.
- 7. It is essential for all students to wear blue apron (Lab coat) during theory class, practical class and in the lab/hospital.
- 8. For enrollment in the MPMSU / MPPMC, student will have to submit Transfer certificate (T.C.) and Migration certificate in original. In case of deficit of above documents, if enrollment of student is not done then students themselves are responsible.
- 9. For all paramedical courses, students have to do 3 month Internship / clinical posting in the associated hospital after successful completion of course.
- 10. Students of degree and diploma courses will have to undergo successful completion of course and Internship / clinical posting for getting degree / diploma from MPMSU, Jabalpur.
- 11. Students of certificate courses will have to undergo successful completion of course and Internship / clinical posting for getting certificate from MPPMC, Bhopal.
- 12. After successful completion of course, students and In-service candidates will have to necessarily do registration in MPPMC, Bhopal through MP online portal.

DISCIPLINARY CONTROL

RIGHT TO MAKE RULES

Government Medical College, Khandwa Autonomous Society will have the right to make new rules, amend existing rules or number of seats at any time during the course, which will be binding on the students. In case of any dispute it will be under jurisdiction of Khandwa.

GENERAL INSTRUCTIONS

- 1. Candidate is not permitted to take admission simultaneously in any other course in any university/college/board.
- 2. If candidate will leave the course after admission or failing to pay fee in time or remains absent, admission of such student will be cancelled and no refund of the fee already paid will be made.
- 3. Rs.5,000/- caution money deposit will be charged at the time of admission only.

Note:- The money of actual damage by trainee will be recovered from caution money time to time & the balance Rs.5,000/- has to be maintained.

- 4. Students will be charged enrolment fee and exam fee from time to time.
- 5. Fee once deposited will not be refunded to the candidates.
- 6. Hostel facility is not guaranteed.
- 7. After publication of Merit list on the website there will be period of two days for submission of queries by the applicants.
- 8. 10% seats are reserved for departmental in service candidate. Joining will be allowed after submission of relieving certificate from the employer.
- 9. Admission will be done as per merit list through counseling. Application form can be downloaded from Government Medical College, Khandwa website www.gmckhandwa.org,
- 10.
